hereinafter referred to as "Mare Owner" and SAX Morabs, Donna J. Lassanske, 256 Galloway Rd,  
Stamping Ground, KY. 40379 hereinafter referred to as "Stallion Manager".

### WITNESSETH

Whereas, Donna J. Lassanske (SAX Morabs), hereinafter referred to as "Stallion Owner", is the owner of the stallion named SAX Gold Dust PMHA # 828, IAHA # 1A 339167, IAHA Sweepstakes Nominated Stallion, hereinafter referred to as the "Stallion", whereas such stallion shall stand at a designated location determined by training schedules if other than the premise of the Stallion Owner, whereas the owner of the premise, hereinafter would be designated as the "Premise Manager", may have Mare Care fees and vaccination/Coggins requirements which will be the responsibility of the Mare Owner, and whereas, Mare Owner has the following ownership rights to the following said mare.

Whereas, said Stallion will stand at stud for the current breeding season from April 15 to September 15. This period shall be defined as the normal breeding season (hereinafter referred to as the "breeding season"). Any extension of the breeding season for any Mare or for any reason shall be at the sole discretion of the Stallion Manager.

**THE PARTIES HERETO AGREE AS FOLLOWS:**

## FEES:

**Single Mare Breeding Fee:** \$500.00.

The Stallion Owner hereby grants Mare Owner one season's booking during Mare's Breeding Period for Stallion's servicing of Mare, and hereby guarantee a live foal pursuant to the LIVE FOAL GUARANTEE section of this agreement.

A special breeding fee can be arranged in certain circumstances.

Contract and fee is payable **one month** prior to expected breeding. Collection and shipment will **not** be fulfilled without prior payment.

The Breeding Fee of \$500 shall be payable as follows: **Applicable year** \_\_\_\_\_

**Multiple Mare Discount**

Two or more mares of same owner, breeding fee reduced \$100 for second mare, breeding fee reduced \$125 for third mare and same for any mare thereafter.

## CONDITIONS REGARDING FEES

All amounts paid by Mare Owner shall be non-refundable, subject to BREEDING or DEATH, OR INCAPACITY OF STALLION sections hereof this agreement.

In the event that Mare does not conceive during Breeding Season or mare conveys and does not carry the foal to term and for any other reason and Mare Owner desires a return breeding MUST abide by the LIVE FOAL GUARANTEE section hereof. The Mare Owner shall pay the stallion collection and shipment fees directly to assigned veterinary clinic.

## SEMEN SHIPMENT (Cooled)

The following fees shall apply and are payable prior to shipment(s) directly to veterinary clinic.

### The Following Fees are Approximate:

**Collection: \$125**

**Prep to Ship: \$70**

**Disposable shipper: \$45 each**

**Fed Ex Priority Overnight: variable; minimal \$15**

**Centrifugation\* \$130 only if needed**

If shipment going for multiple mares, veterinarian will determine if one shipment will satisfy multiple mare contract.

## **BREEDING**

Stallion Manager may request that the prospective mare show proof of a clean culture or in problem mares a biopsy to determine breeding soundness. Stallion Manager also reserves the right to refuse to continue service to any Mare upon detection of Mare carrying an infectious and/or contagious disease, or if any other applicable reason applies. In the event of such service discontinuance, the Mare Owner is obligated to substitute another Mare to fulfill the terms of this Agreement.

The Stallion Owner reserves the right to move the Stallion from one premise to another for a period of time necessary to train, show and/or promote the Stallion in the best interest of the Stallion Owner. During this time, Mare Owner understands that Mares that come into heat may not be bred during this particular heat cycle. It is Mare Owner's responsibility to check on availability of Stallion for breeding during these times.

## **LIVE FOAL GUARANTEE**

### **Conditions for live foal guarantee:**

1. Breeding of mare is followed up with an ultrasound within 30 days (forwarded to Stallion Manager) of breeding date for determination that mare settled
2. Mare owner obtains laboratory blood work of adequate hormonal levels that sustain a pregnancy within 90 days of bred date
3. Stallion Manager reserves the right to ask for a veterinarian's statement regarding Mare's condition/non-pregnant status at any time.
4. Vaccination of Mare for Rhinopneumonitis in the fifth, seventh, and ninth months of the Mare's pregnancy. It is recommended that rotavirus is also given to the mare. Stallion Manager may ask for proof of said vaccinations.
5. In the event that Mare does not produce a "Live Foal", then Mare Owner shall provide Stallion Manager with a veterinarian's certificate stating the time and date of birth, time and date of death, and cause of death within seven calendar days of such death.

Should the Mare fail to conceive, absorb, abort, die, or not produce a "Live Foal" (Live foal shall be defined as a foal that stands and nurses without assistance for a period of at least 24 hours from the time of birth) then the Stallion Owner guarantees that Mare Owner shall have the right to rebreed or substitute a mare (upon the approval of the Stallion Manager) within the current or the following breeding season or a breeding season mutually agreed upon..

Live Foal Guarantee shall be specifically conditioned upon Mare Owner's compliance with above conditions. Non compliance of Live Foal Conditions shall void any rebreed opportunity of this contract.

### **Other conditions that will void said contract:**

1. Mare is bred by any other stallion without written consent by Stallion Manager prior to rebreed.
2. Mare is substituted with another mare without written consent by Stallion Manger.
3. Mare fails to conceive, absorbs, aborts, or dies and Mare Owner fails to notify Stallion Manager as defined in this section.

## **TRANSPORTED SEMEN**

Stallion Manager shall provide semen from Stallion identified in this contract, and makes no other guarantee of the condition of the semen once the disposable container has left the of premise of collection or qualified veterinary service.

Stallion Manager shall have stallion professionally collected and transport semen on days with best expected delivery in a timely manner. Stallion Manager reserves the right to not collect or transport semen on Holidays.

Mare Owner shall request collection and transported semen **48 hours** prior to expected shipment. Stallion Manger reserves the right to ask for veterinarian evaluation of mare cycle/ovulation, either per palpation or ultra-sound (proof of adequate follicle development). Stallion Manager does not guarantee a semen shipment if a request is not received **48 hours** in advance. Stallion Manager shall provide semen on a "first come, first serve" basis and shall not guarantee semen to Mare Owner if the Stallion is overbooked on that particular day.

It is the Mare Owner's sole responsibility to insure proper handling and insemination of the semen into the Mare.

## **DEATH OR INCAPACITY OF STALLION**

Should Stallion die, or become incapacitated before Mare is first serviced pursuant to this Agreement, this Agreement shall be terminated and the Stallion Owner shall return the portion of the breeding fee paid by Mare Owner. Should the Stallion die, or become incapacitated after servicing of Mare and Mare does not produce a Live Foal pursuant to this Agreement, then Stallion Owner shall return the portion of the breeding fee paid by Mare Owner and any outstanding miscellaneous fees.

## **INDEMNITY**

The Stallion Manager, or any other Premise Manger as directed by the Stallion Owner, and its owners, principals, agents, employees, veterinarians, farriers, and Stallion Owner shall not be liable for any sickness, disease, estray, theft, death, or injury which may be suffered by Mare and/or Foal during the time that Mare is in the custody of Stallion Manager or Premise Manager, or for any other cause of action whatsoever arising out of or in any way connected with breeding, boarding, conditioning, training, transporting, or providing any other services to Mare and/or Foal. This includes, but is not limited to, any personal injury or disability that Mare Owner, its agents or employees may receive while on the premises of Stallion Manager or Premise Manager. Mare Owner fully understands that Stallion Manager or Premise Manager does not provide any public liability, accidental injury, theft or equine mortality insurance for Mare and/or Foal , and that all risks connected with breeding, boarding, conditioning, training, transporting, or providing any other services to Mare and/or Foal are to be borne solely by Mare Owner.

This Agreement constitutes the entire agreement between both parties and may not be modified except in writing, signed and agreed upon by all parties.

## CONTRACT SIGNATURES
